




Individual Support of Higher Education, Giving in Billions; 2014 Dollars

1974-2014)




## **Philanthropic Dollars Matter**

- Unrestricted annual giving programs make up more than 10% of current operations at US colleges and universities.
- Combined with restricted gifts and interest from endowment—a result of prior philanthropy—the percentage of annual budgets stemming from giving increases dramatically.



University Funding Burden Shift to Students (Moody's, 2011)





### THE ISOMORPHIC ARGUMENT: STRIVING FOR PRESTIGE & LEGITIMACY

# The Isomorphic Argument: Striving for Prestige & Legitimacy

 "As an innovation spreads, a threshold is reached beyond which adaptation provides legitimacy rather than improves performance" (DiMaggio & Powell, 1983)

# Institutions Striving for Prestige & Legitimacy: The Rankings Pursuit

US News & World Report ranking formula:

- Explicit use of philanthropy: Alumni giving (5%) as a means to determine graduate "satisfaction"
- Implicit use of philanthropy:
  - Financial resources (10%)
  - Academic reputation (22.5%)

Institutions Striving for Prestige & Legitimacy: The Rankings Pursuit

Global rankings such as *The Times of Higher Education:* 

- Explicit use of philanthropy: None
- Implicit use of philanthropy:
  - Academic reputation (33%)

# Institutions Striving for Prestige & Legitimacy

- United States:
  - 75% of the \$500 billion in endowment wealth these days is held by just 11% of colleges (Congressional Research Service, 2015)
  - More than 25% of the \$41 billion raised by colleges last year went to just 20 institutions (VSE, 2017)
- United Kingdom
  - 78% of new philanthropic gifts secured by 18 institutions (ROSS-CASE, 2016)

# **Striving for Prestige & Legitimacy**

- Universities in Hong Kong, Singapore, and China are well-funded by their governments yet institutions are seeking endowment funding for research and scholarships for ranking purposes (Sharma, 2011)
- All three governments encourage giving by matching gifts with government funding

– Singapore - 1.5 times match

 "People do not give to poor universities, they give to excellent universities." – Peter Cheung, Hong Kong Secretary General for Continuing Education in Tertiary Institutions

# The Borrowing & Lending Argument: Adoption of "Best Practices"

- Institutions and countries are "Borrowing and Lending" (Steiner-Khamsi, 2004; 2015) best practices of fundraising mostly from the United States
  - The proliferation of CASE offices, memberships, and conferences around the world
  - Investment of The Carnegie Corporation in fundraising training and infrastructure


- Currently Little Research on Individual Giving Outside of the U.S. Context








## **Public FTE Enrollment & Educational Appropriations** Per FTE, 1989-2014; 2014 **Dollars** (SHEEO, 2014)


